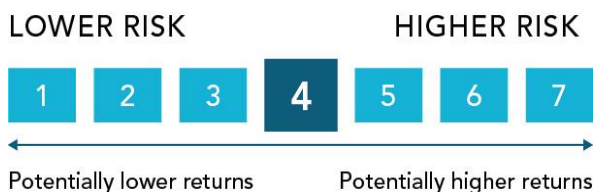

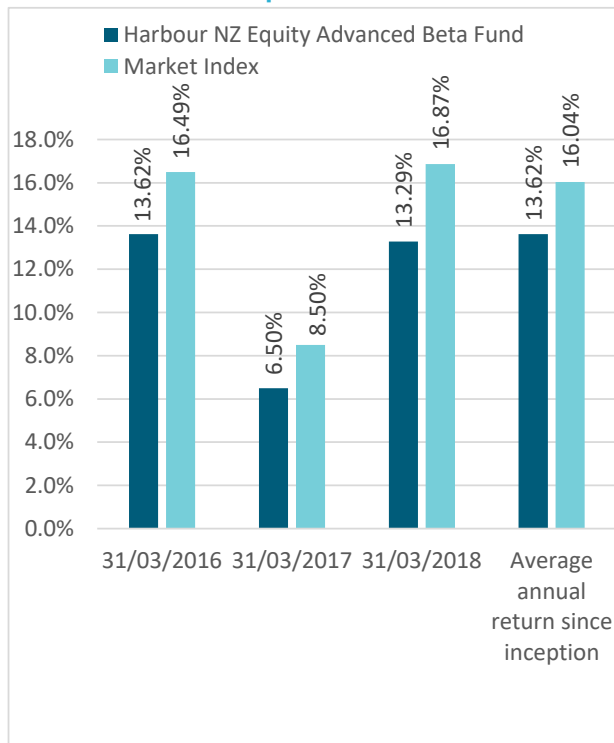

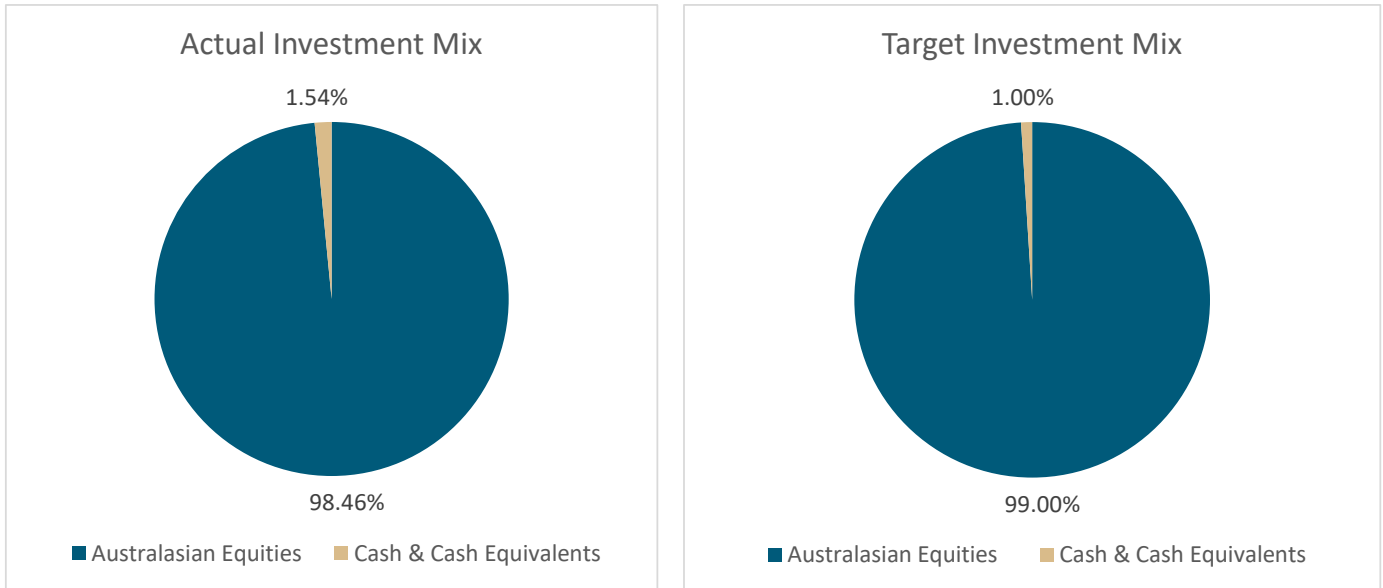

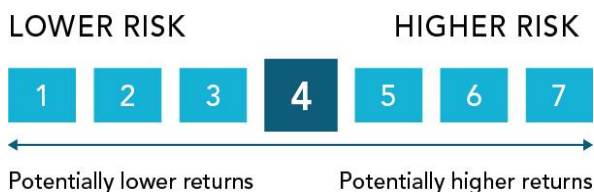

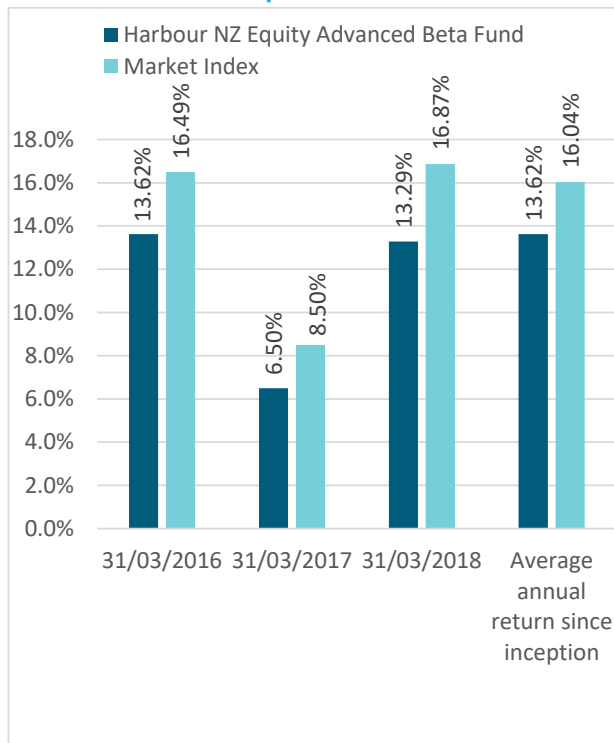

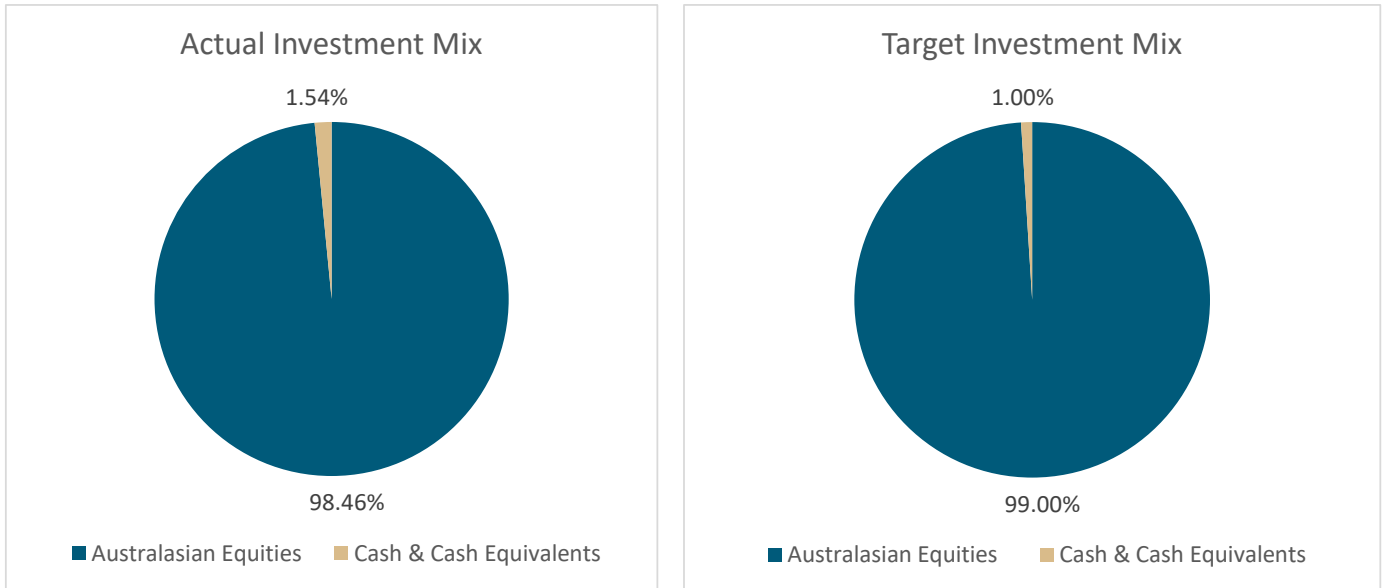

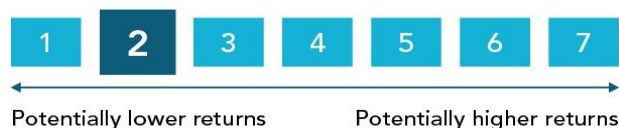

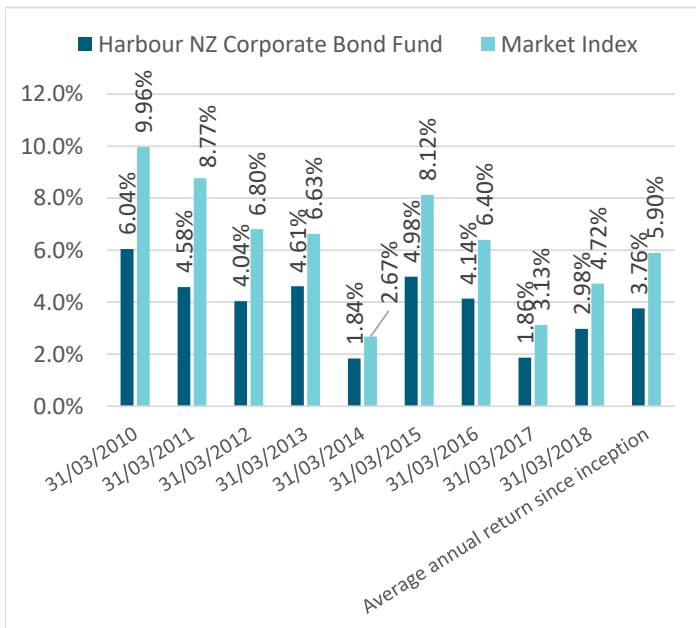

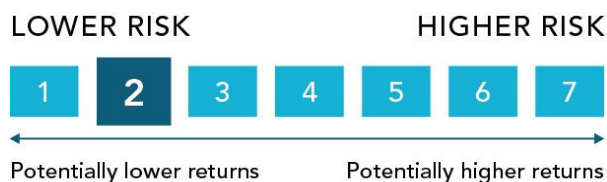

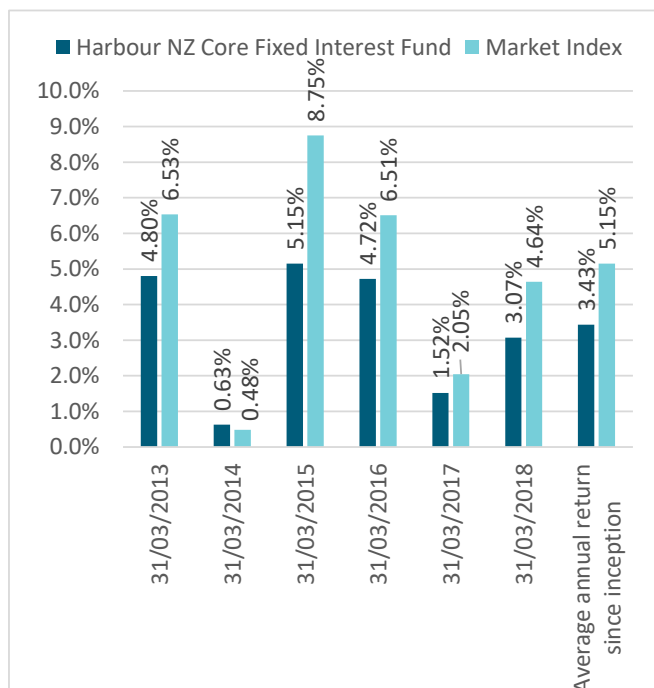

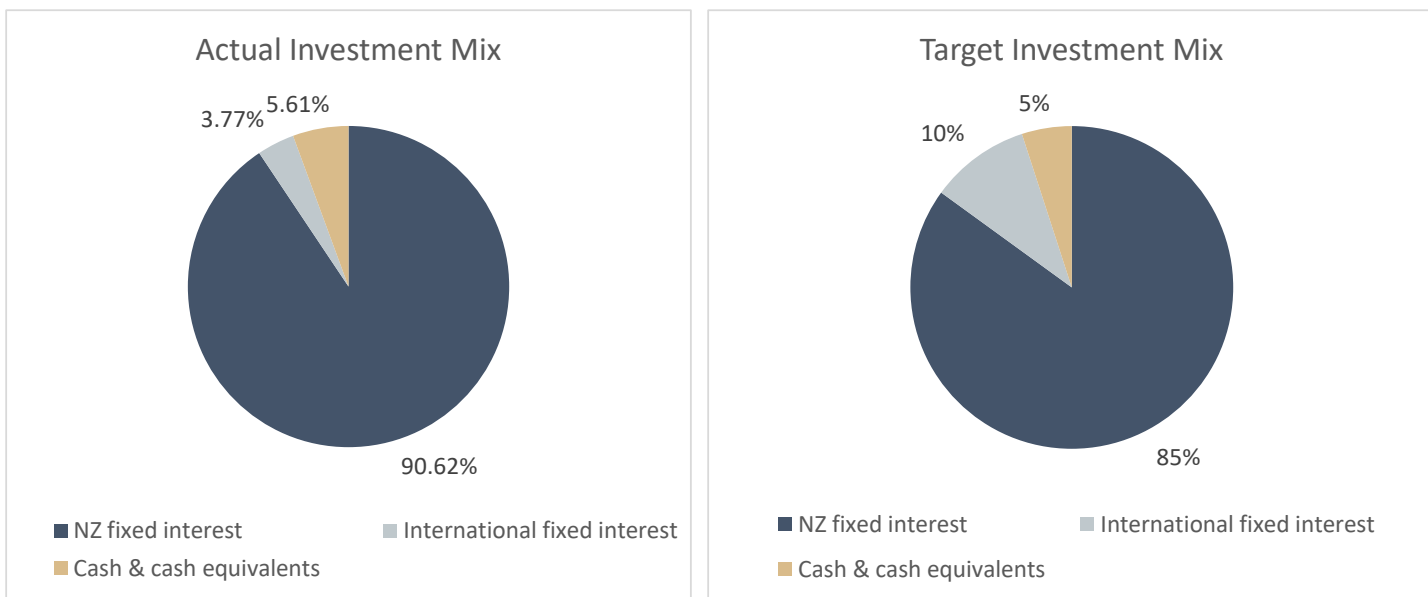

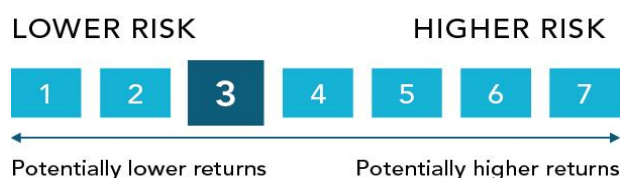

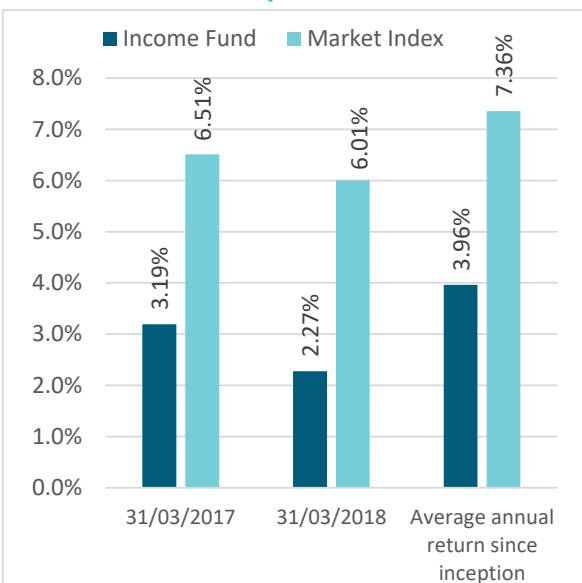

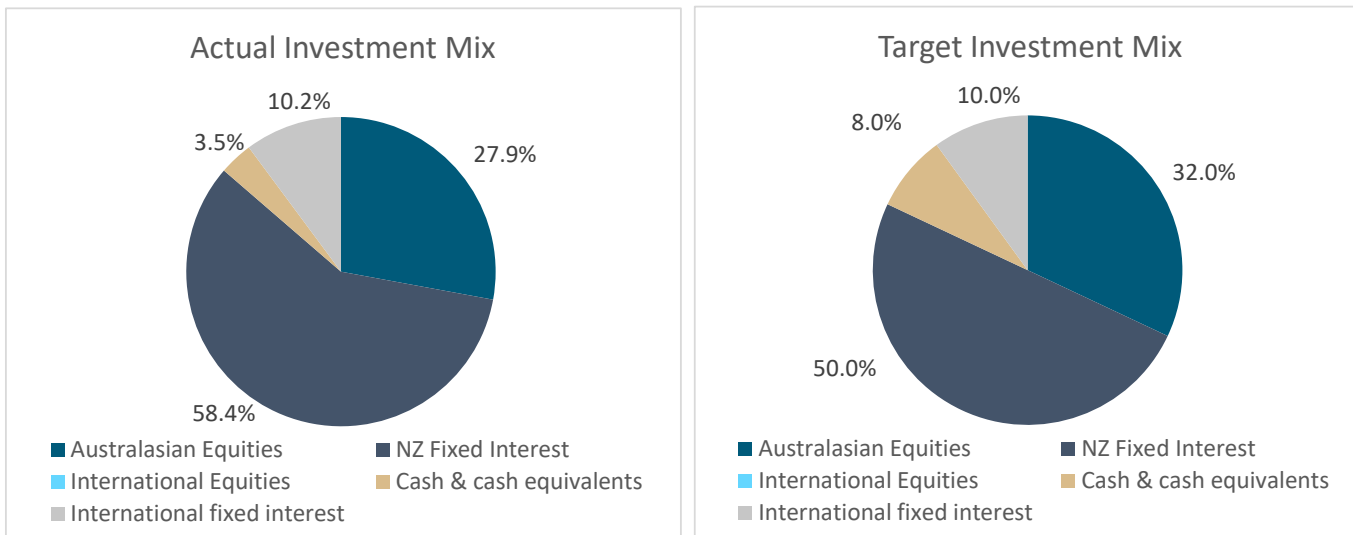

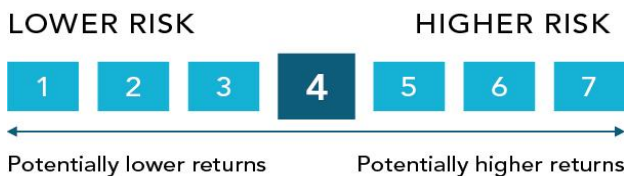

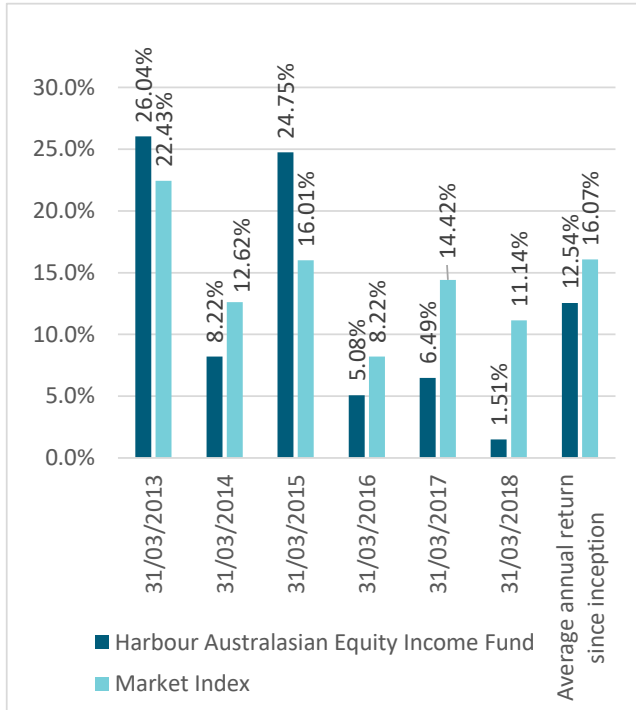

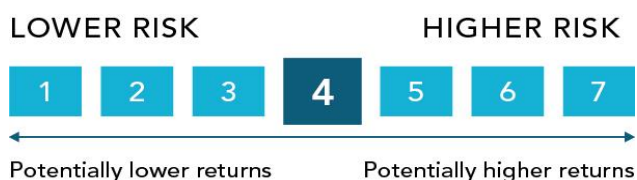

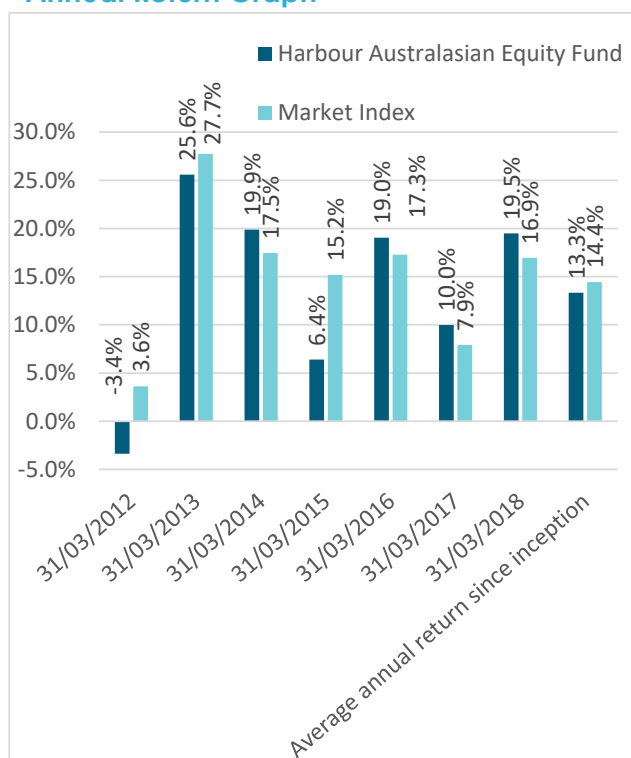

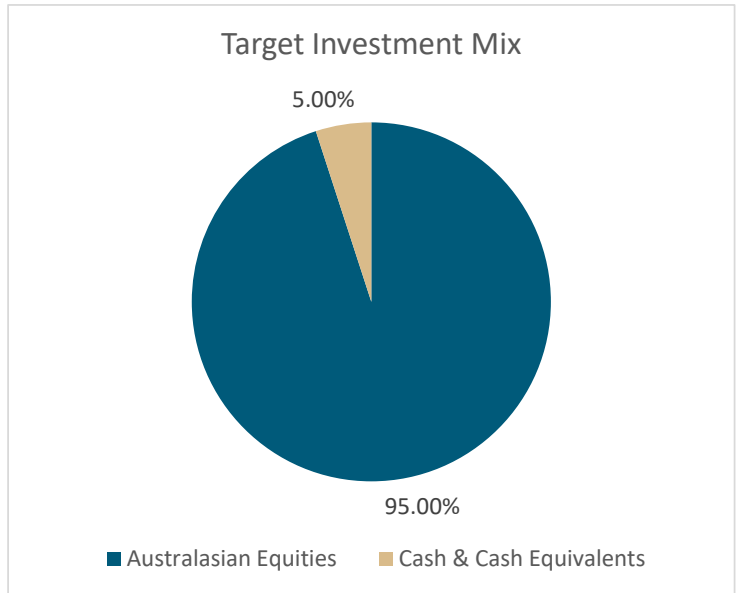
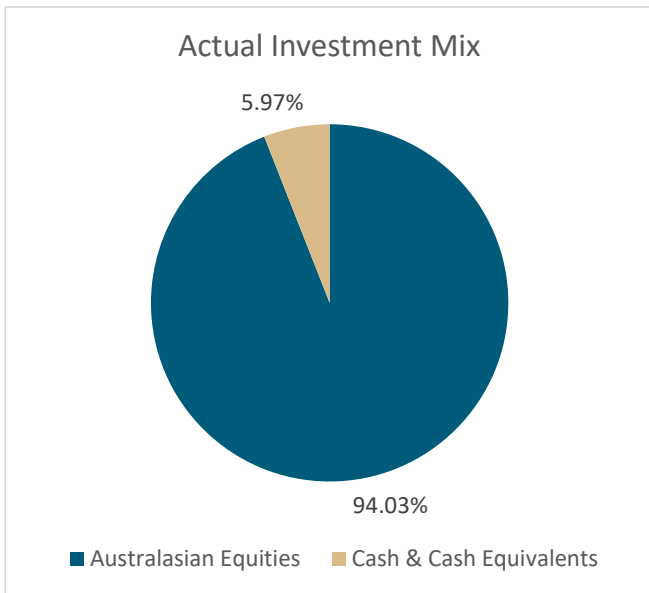
## Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Jenny had \$10,000 in the Harbour Australasian Equity Focus Fund at the start of the year and did not make any further contributions. At the end of the year, Jenny received a return, after fund charges were deducted, of \$2,839 (that is 28.39% of her initial \$10,000). This gives Jenny a total return after tax of \$2,823 for the year.
