The investment objective of the Fund is to deliver medium to long term capital growth through investing in quality businesses with strong growth prospects.

Fund Update

Portfolio performance was ahead of the benchmark for the month. Strong returns from a2 Milk, Xero, Macquarie Volpara and Aristocrat boosted performance. Weakness in Summerset, Pacific Edge, Mainfreight, Contact and Sanford dragged on returns.






Absolute Sector Weights %
