

# Harbour Australasian Equity Focus Fund

## MONTHLY FUND FACT SHEET

### Fund Description

The Fund is an actively managed fund investing in New Zealand and Australian listed equities. It is a high conviction fund where the portfolio will consist of companies our analysts have researched and have a high belief will perform over the medium to longer-term. A higher rated company will have a higher weighting in the portfolio. The Fund incorporates an environmental, social and governance (ESG) strategy involving integration of Harbour's proprietary Corporate Behaviour Survey and external provider scores into investment decision making, company engagement, voting and zero tolerance exclusions<sup>1</sup>.

### Benchmark

50% S&P/NZX 50 and a 50% S&P/ASX 200 Index (which is 50% hedged into NZ dollars).

### Fund Objective

The investment objective of the Fund is to deliver medium to long term capital growth through investing in quality businesses with strong growth prospects.

### Fund Update

Portfolio performance was ahead of its benchmark for the month and quarter. Performance was influenced by companies providing earnings upgrades and capital raisings for acquisitions offset by weakness in technology stocks. Investments in outperformers Ebos, Macquarie, Summerset, Vulcan Steel and Mainfreight drove performance over the month. Positive contributors over the quarter were similar whilst also including investments in Charter Hall and Goodman Group. Investment in IT and health stocks dragged on returns.

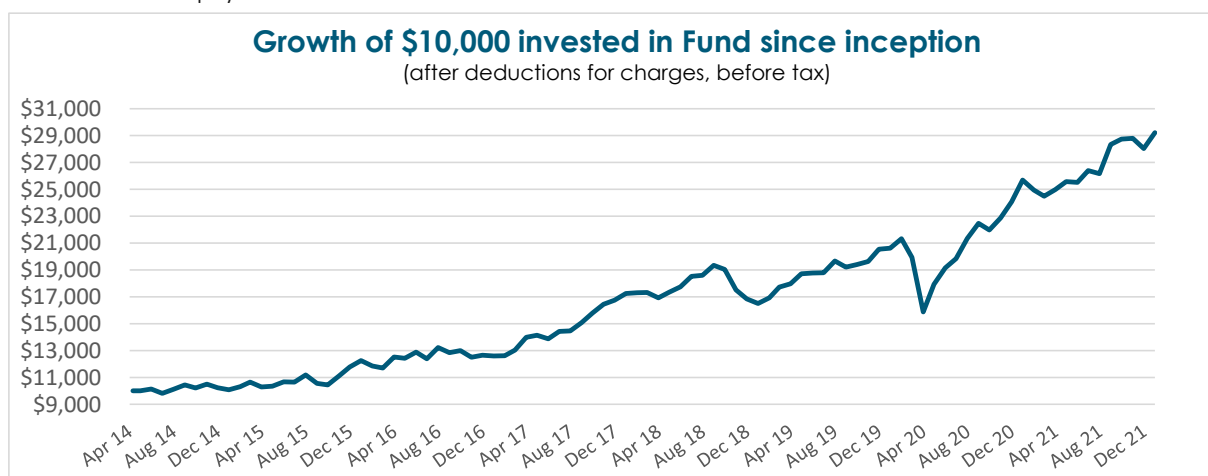

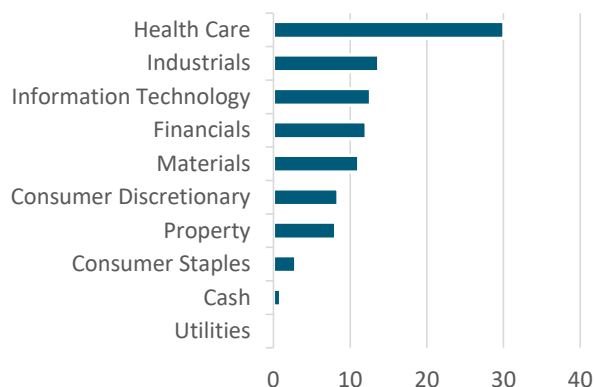

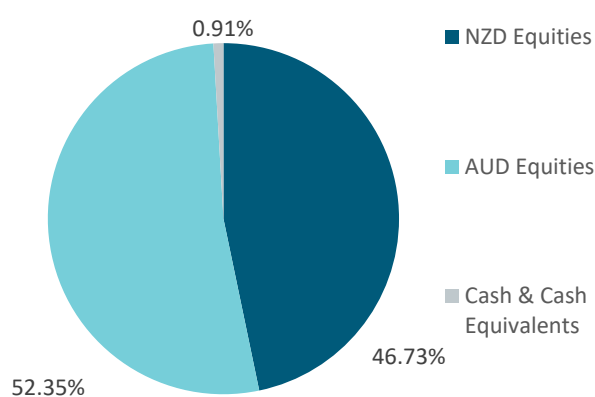
