












































Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Jenny had \$10,000 in the Harbour T. Rowe Price Global Equity Fund at the start of the year and did not make any further contributions. At the end of the year, Jenny incurred a loss, after fund charges were deducted, of \$2,307 (that is -23.07% of her initial \$10,000). This gives Jenny a total loss after tax of \$2,388 for the year.
