What is the purpose of this update?

This document tells you how the Harbour Real Estate Investment Fund has performed and what fees were charged. The document will help you compare the Fund with other funds. Harbour Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund aims to capture the income yield and medium-term capital growth characteristics of investing principally in listed real estate assets and enhance diversification and return potential against the benchmark.

Investment Objective: To exceed the benchmark return plus 1% per annum over the medium term.

Benchmark: S&P/NZX All Real Estate Index.

Total value of the Fund (NZD) \$ 125,663,616

What are the risks of investing?

Risk indicator for the Harbour Real Estate Investment Fund



The risk indicator is rated from **1** (low) to **7** (high). The rating reflects how much the value of the Fund's assets goes up and down. 
How has the Fund performed?

This shows the return after Fund charges and tax for each year ending 31 March since the Fund started.

The last bar shows the annualised annual return since the Fund started, up to 31 December 2024. Market Index returns do not include any tax, expenses or charges.


Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Jenny had \$10,000 in the Harbour Real Estate Investment Fund at the start of the year and did not make any further contributions. At the end of the year, Jenny received a return, after fund charges were deducted, of \$107 (that is 1.07% of her initial \$10,000). This gives Jenny a total return after tax of \$66 for the year.

What does the Fund invest in?

This shows the types of assets that the fund invests in.
